I hereby agree to rent snowshoes, poles and carrying bag and return them in the same condition as rented. I have inspected the equipment and I authorize and grant permission for the Sun Prairie Parks, Recreation & Forestry Department to cash my deposit and bill me for any necessary repair costs that are higher than the deposit in the event of damage due to neglect, misuse or loss. If equipment is returned late, I understand that I will be billed an additional \$5/day/pair for each late day for a maximum of 10 days. After 10 days, the item(s) will be considered lost and I will be billed the full replacement cost (up to \$110). I fully release and discharge the City of Sun Prairie and its officers, agents and employees from any and all claims and damages, including claims and damages arising from injuries, death, or property damage, which may arise out of, or occur in connection with my use of Sun Prairie's snowshoes, except for those resulting from the intentional or reckless acts of the City of Sun Prairie or its officers, agents and employees.

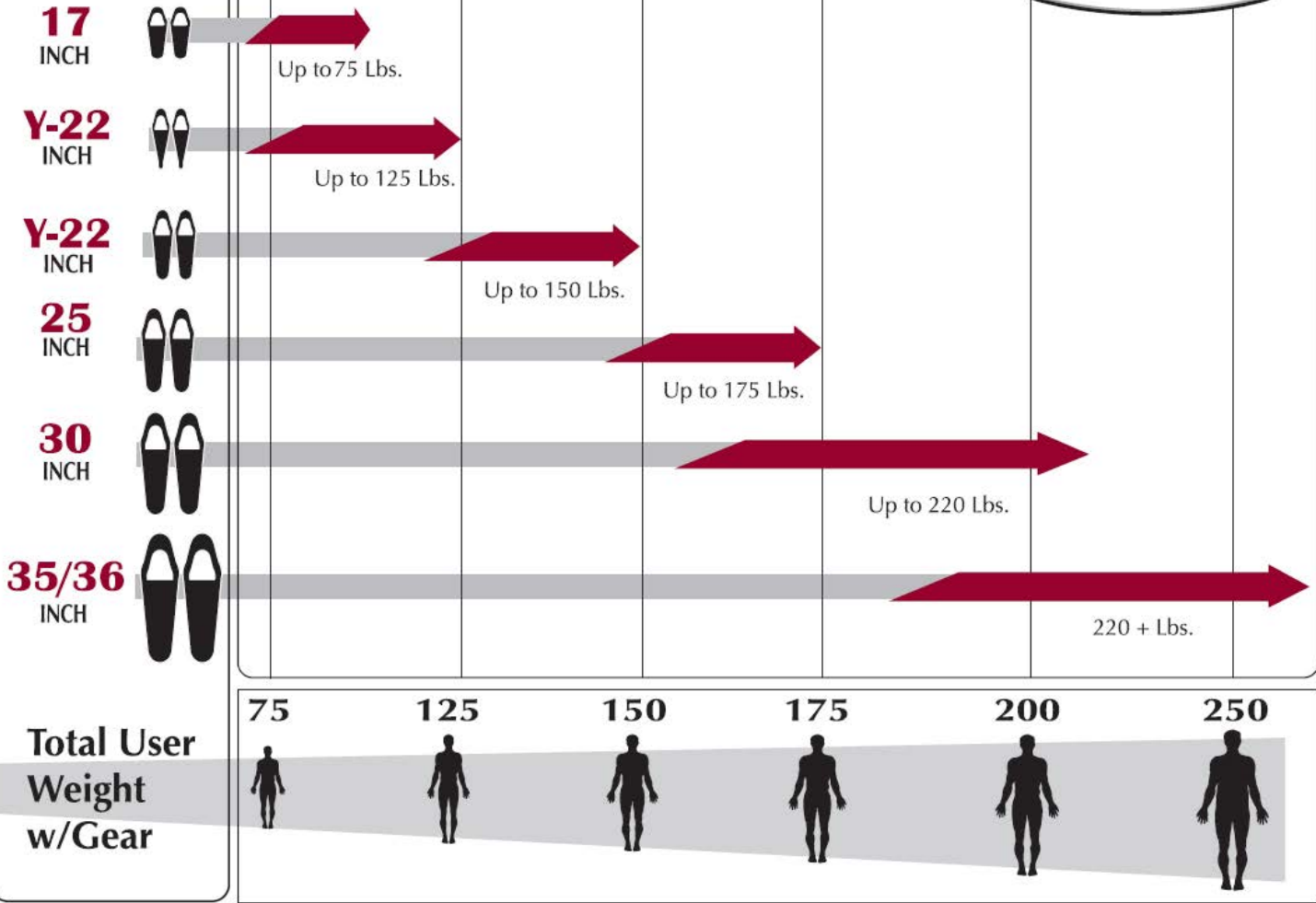
Snowshoes must be returned to the Sun Prairie Parks, Recreation & Forestry Department, located at 2598 W. Main Street, Sun Prairie, WI 53590, during business hours of 8:00 am-4:30 pm. Questions, please call 608-837-3449.

Parks, Recreation & Forestry staff will do a check-in inspection upon return. If snowshoes are returned damaged, repair fees will be withheld from the deposit. If repair costs are higher than the deposit, additional charges may be billed to renter. If snowshoes are not returned, the renter will be charged for the replacement pair of snowshoes.

By signing this Waiver of Liability, I agree to waive, relinquish, discharge, release and covenant not to sue the City of Sun Prairie, Wisconsin, its officers, employees and agents from all claims of injury, damage, or loss that may accrue arising out of, connected with, or in any way associated with the activities with the City of Sun Prairie Parks and Recreation Department as identified in this Waiver of Liability. This waiver of liability does not apply intentional misconduct of the City of Sun Prairie.

Medical Emergency Release Waiver for Minors

In the event of a medical emergency, I authorize the Parks and Recreation Department staff to obtain medical treatment for myself or my son/daughter or minor for which I am a guardian.

Photographic Release
